

Recreational Opportunities

Bird Watching – Bicycling – Fishing – Hiking
Horseback Riding – Hunting – Outdoor Photography
– Shooting Range

Conservation areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing and hunting activities.

- No littering.
- No fireworks.
- No open fires. Pitted fires only in designated areas.
- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, mushrooms and wild greens may be taken for personal consumption only.
- Motor vehicles are restricted to roadways and parking areas.
- Horseback riding and bicycles are allowed only on trails designated for their use and on roads and trails open to vehicular traffic, unless otherwise posted.
- Swimming, sailboarding, scuba diving, water skiing, rappelling, water skiing, paint-balling or skateboarding are not allowed.

Fishing and Boating

Area is open to fishing under statewide regulations. The following special regulations also apply:

- Other restrictions may apply to specific ponds, lakes and stream segments.
- Bullfrogs and green frogs may be taken during the statewide season only by hand, handnet, atlatl, gig, bow, snagging, snaring, grabbing, pole and line, a twenty-two (.22) caliber or smaller rimfire rifle or pistol, pellet gun, or crossbow, only on waters and within dates and hours those waters are open to fishing or hunting.
- Seining or trapping live bait, including tadpoles, is prohibited on all impounded waters and their discharge channels.
- Salvage seining of non-game fish for personal use is permitted only with written permission of the Conservation Department.
- Boats may be used for fishing and wildlife-related activities only and may not be stored or left unattended overnight.

Hunting and Trapping

Area is open to hunting under statewide regulations. The following special regulations also apply:

- Deer may be hunted only with archery and muzzle-loading methods. All other statewide seasons and limits apply.
- Only portable tree stands may be placed or used and only between Sept. 1 and Jan. 31. Each stand must be identified with the name and address and/or conservation number of the user and must be removed from the area by Feb. 1. Use of nails or other materials that would damage the tree is prohibited.
- Trail and game cameras are prohibited.
- Decoys and portable blinds are permitted but must be removed from the area daily. Blinds may be constructed on-site, but only from willows and non-woody vegetation.
- Trapping of furbearers is permitted only as specifically authorized by special use permit.

Shooting Range

- Unstaffed disabled accessible range; archery, firearms 25, 50 100 yds. and shotgun.
- Range open 1/2 hour before sunrise to 1/2 hour after sunset.
- Range closed Monday until noon for maintenance.


