Rules and Regulations

Conservation areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing, and hunting activities.

- No littering.
- No fireworks.
- No open fires.
- No free-running pets.
- Dogs must be leashed or confined when not being used for hunting or training.
- Motor vehicles are restricted to parking areas.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, edible wild greens and mushrooms may be taken only for personal consumption.
- Removal of water and the collecting of plants, animals or artifacts are not allowed.
- No camping permitted.
- No target shooting allowed.
- Horseback riding is not permitted.
- Trail and game cameras are prohibited.

Hunting and Trapping

Area is open to deer and turkey hunting only. These activities are further restricted by the following regulations:

- Deer hunting is permitted under statewide seasons and limits except: only archery and muzzle-loading methods may be used. Firearms antlerless and archery antlerless permits may not be used.
- Only bucks that have at least four antler points on one side of their rack may be taken during the archery and firearms deer hunting seasons (except the youth portions).
- Only portable tree stands are allowed and only from September 1 through January 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be

removed from the area before February 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.

- Turkey hunting by archery method only.
