## Rules and Regulations

*Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized fishing and hunting activities.*

- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting. The training of hunting dogs is permitted only by holders of a Missouri small game hunting permit.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, edible wild greens and mushrooms may be taken only for personal consumption.
- No target shooting allowed.
- Vehicles and bicycles are restricted to roadways and parking areas. No vehicles or bicycles are allowed off-road.
- Horses and horseback riding is prohibited.
- Collecting plants, animals or artifacts, removing water and digging or otherwise disturbing the soil are prohibited.
- No littering, dumping, fireworks, open fires, camping, swimming and waterskiing.
- Trail and game cameras are prohibited.

## Fishing and Boating

*Fishing and frogging are allowed under statewide regulations with the following exceptions:*

- Fish may be taken only by pole and line and not more than three poles and lines may be used by any one person.
- Daily limits are six black bass and four catfish in the aggregate (channel, blue and flathead catfish) and 30 crappie. All other fish fall under statewide limits, but the total number taken may not exceed 20.
- Black bass between 12 and 15 inches in total length must be returned to the water unharmed immediately after being caught.
- Bullfrogs and green frogs may be taken during the statewide season only by hand, handnet, atlatl, gig, bow, snagging, snaring, grabbing and pole and line.

- Firearms may not be used to take bullfrogs and green frogs.
- Seining or trapping live bait, including tadpoles, is prohibited.
- Salvage seining of non-game fish for personal use is permitted only with written permission.

## Hunting and Trapping

*The following special regulations apply:*

- No firearm hunting allowed. Archery methods only. Season and limits apply.
- Deer hunting is permitted under statewide seasons and limits except: only archery methods may be used. The use of antlerless permits is allowed.
- Turkey hunting is permitted under statewide seasons and limits except: archery methods only.
- Only portable tree stands are allowed and only from Sept. 1 through Jan. 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the user and be removed from the area before Feb. 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Decoys and portable blinds are permitted but must be removed from the area daily. Blinds may be constructed on-site, but only from willows and non-woody vegetation.
- Trapping of furbearers is permitted only as specifically authorized by Special Use Permit.


