

## Area Highlights

## Recreational Opportunities

Bird Watching – Fishing – Hiking

*Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized fishing and hunting activities.*

- No hunting.
- No fireworks.
- No open fires.
- Horseback riding and bicycles are permitted on service roads and roads open to vehicles.
- Dogs must be leashed when not used for training.
- Nuts, berries, fruits, mushrooms and wild greens may be taken for personal use. Cutting or removing other vegetation is prohibited.
- Motor vehicles are allowed on public roads and in parking areas.
- Camping is prohibited.
- Target shooting is not allowed.
- Swimming, scuba diving, water skiing, sail-boarding, skateboarding, caving and rappelling are prohibited.

## Fishing and Boating

*Fishing and frogging are permitted under statewide regulations with the following exceptions:*

Species	Daily Limit	Length Limit
Largemouth bass	2	18" Minimum
Channel catfish	4	None
Crappie	30	None
Other fish	10 total	None

- All largemouth bass less than 18 inches total length must be released immediately after being caught.
- Head and tail must remain attached to all largemouth bass while on the area or until checked by an agent of the Conservation Department.
- Fish may be taken only by pole and line and not more than 3 poles may be used by any person.
- Boats may be used for fishing and wildlife-related activities only and may not be left unattended overnight.
- Bullfrogs and green frogs may not be taken with firearms, trotlines, limblines or juglines.
- Seining or trapping live bait, including tadpoles, is prohibited on area lakes and ponds. Gizzard shad may be taken from lakes and ponds by dip net or throw net.
- Only electric motors are permitted.

## Hunting and Trapping

*Area is closed to hunting.*

The 225-acre Port Hudson Lake Conservation Area is located in Franklin County northeast of Gerald on Bald Hill Road. It can be reached by taking Highway C north from Highway 50 to Bald Hill Road or by taking Highway C south from New Haven to Bald Hill Road and proceeding one mile west.


